Waiver of Release and Liability**

Acceptance of Risk; Release; Indemnifications:

The safety and security of the children in the care of First Presbyterian Church (FPC) remains a constant priority. I understand that there may be significant risk associated with my child's return to programs and activities at FPC, including but not limited to increased social contact with staff, volunteers and other children. To help reduce the spread of Covid-19 and to protect said staff and children, FPC encourages all families to practice safety and health guidelines for the prevention of Covid-19 as provided by the Georgia Department of Public Health and the Centers for Disease Control and Prevention. Following the recommended preventive measures will allow all to do their respective part in reducing the spread of Covid-19.

Notwithstanding the foregoing, I understand that the above guidelines do not completely eliminate my child's risk of exposure. Should my child experience any symptoms of Covid-19 (fever, cough, body aches or shortness of breath), I am advised to keep my child at home and follow the advice of a healthcare professional.

Regardless of all steps taken by FPC to reduce the risks of infection, I am fully aware that there are risks associated with my child's attendance during the Covid-19 pandemic, including without limitation, being exposed to and contracting Covid-19 from other individuals, surfaces and/or airborne particles.

I knowingly and freely assume all such risks relating to my child's participation at FPC arising from or relating to Covid-19. I hereby forever release, waive relinquish and discharge First Presbyterian Church, Thomasville, its officers, members, staff or other representatives and their successors and assigns from any and all claims, demands, liabilities, rights, damages, expenses and causes of action of whatever kind or nature and losses as a result of my child's attendance at First Presbyterian Church, Thomasville, GA.
